

Rental terms and conditions

Définitions :

Lessee : the customer who rents items from GMAX Rentals.

End users : the people who use the items rented by the customer of GMAX Rentals.

Leased items : any article supplied by GMAX Rentals to the customer.

Order documents : one or all of the following forms, including the purchase order, bill of delivery, invoice or special contractual agreement between GMAX Rentals and a customer.

1. Rental fees for leased items are for a one-time use term, unless otherwise specified in writing on the order documents.
2. The lessee agrees to give back all leased items and the containers used to carry these items after use. All damaged or missing items and containers will be charged to the lessee at their replacement price, as listed on the following website link: www.locationgmax.com/replacement.pdf
3. Leased items and the containers supplied to carry these items are under the responsibility of the lessee from the moment they are delivered to the address shown on the order documents until the moment they are picked-up by GMAX Rentals after use.
4. The lessee agrees to keep all leased items and the containers supplied to carry these items at the location shown on the order documents and not use these items at any other location.
5. The lessee shall not under any circumstances replace or substitute any of the leased items by other items owned by another entity than GMAX Rentals. Items returned to GMAX Rentals which are not owned by GMAX Rentals will not be counted as part of the lessee's initial order.
6. GMAX Rentals may occasionally supply a slightly larger amount of items than the customer ordered, to simplify the order process. In that case, no additional charge will be invoiced to the lessee. However, the lessee is responsible for the total quantity received.
7. The lessee pays a security deposit to GMAX Rentals. However, that security deposit doesn't limit the responsibility of the lessee in regards to broken or missing items. The lessee remains entirely responsible of the replacement cost of the items, even if the total of the broken or missing items is higher than the amount of the security deposit.
8. The lessee has the responsibility to put back all the items in their respective box / containers after use and to put all the boxes / containers together in one place prior to pick-up. A 45\$/hour fee (minimum half an hour, per half an hour increments) will be invoiced to the lessee if GMAX Rentals has to re-pack the items at the agreed time for pick-up. Items, boxes or containers forgotten on-site at the agreed time for pick-up must be returned to GMAX Rentals by the lessee at his/her own expense. Items, boxes or containers forgotten at the pick-up site will be charged at the replacement cost if they are not returned to GMAX Rentals within three days after the original pick-up date.
9. The lessee must notice GMAX Rentals before using the items if one of these items is defective or broken. If it is possible, GMAX Rentals will replace the defective or broken item by a similar one if GMAX Rentals has been noticed by the lessee within a reasonable time frame. If no replacement item is available, GMAX Rentals will credit the rental price of the defective or broken item as long as the lessee has noticed GMAX Rentals before the date and time of use of the items. Under all circumstances, the responsibility of GMAX Rentals is limited to the rental price of the items. GMAX Rentals will not reimburse the lessee if this one didn't notice GMAX Rentals of defective or broken items before the date and time of use of the items. GMAX Rentals reserve its right to verify on site the items deemed defective or broken by the lessee before issuing a credit or replacing the items. GMAX Rentals will make the final decision to replace / credit or not an item.
10. A 10\$ fee per 15-minute increments will be invoiced to the lessee after a 30-minute delay if GMAX Rentals is not granted access to deliver or pick-up items at the time agreed with the lessee.
11. GMAX Rentals will not be held responsible for the damages, accidents or injuries resulting in the direct or indirect use of the leased items by the lessee or the end users.
12. The lessee agrees to pay the full rental price of the total order, even if some or all of these items are not used during the lease period.
13. GMAX Rentals will charge 2% monthly interest, compounded monthly on all invoices which are more than 30 days past due.
14. At its sole discretion, GMAX Rentals may decide not to rent any items to a customer that has past due invoices.
